Village Council Proceedings September 4th, 2012

Regular meeting was called to order by President Kilty at 6:30 P.M.

Roll Call:

Trustees Frome, Gilbert, Hagen, Maurer, Pokallus, and Staples were present

Bids for the sale of the 1988 F700 truck were opened. There were two bid envelopes total. Roland Schafer offered \$1739.00 and Gary Gawlikowski offered \$1751.51.

(Gilbert)(Frome) was carried to accept the bid offer, by Gary Gawlikowski, as the high bidder

(Staples)(Pokallus) was carried to accept the minutes as read

Citizen Comments:

Gene Allar inquired about snow removal for the sidewalk on Hwy 13

<u>Public Works Report:</u>

Chris Helgestad reported that FBC Industries and Land O Lakes are doing well in regards to their sewer discharges. He added that toxicity testing will not be required for the rest of the year

Chris reported that the clarifier tanks have been cleaned and inspected. Mr. Helgestad informed the Board that the preliminary draft permit has been written and will be finalized in the near future

Chris spoke about the wet testing. The amount of wet testing will be reduced; therefore the Village will see some cost savings associated to the process

Dean Smith's report was read and discussed. He made a recommendation to pursue a replacement pump system for well #4. The matter will be sent to the appropriate committee
