Minutes of the Regular Board of Trustees October 20, 2014

Meeting was called to order by President Frome at 6:30 pm

Roll Call:

Trustees Pokallus, Schafer, Day, Hagen and Toufar were present. Trustee Maurer was absent

Minutes:

(Pokallus)(Toufar) was carried to dispense the reading of the minutes and approve them as printed

Citizen Comments:

Pam Warrichaiet inquired about forfeiting her current kennel license. She wanted to know the likelihood of obtaining a kennel license in the future, if she did not initially renew her current license. President Frome advised Mrs. Warrichaiet to take some time to think about her decision

Dennis Dieringer, Town of Spencer Chairperson, asked the Village Board if town residents could receive access privileges to the Village's compost facility. It was told to Mr. Dieringer that this subject was discussed at previous committee meetings. The Board mentioned that the compost facility is funded by village tax payers. Costs such as chipping the brush pile, as well as crushing the concrete pile, were highlighted

Public Works Report:

Chris Helgestad reported that the Sewer Utility has cleaned approx. 20 percent of the collections system with the new sewer jetter. 20 percent of the collections system is the annual goal for the sewer department. Chris also offered a spreadsheet that identified the increase in operating costs attributed to inflow and infiltration of clear water into the collections system. Chris's chart shows that Inflow and Infiltration has ranged from 5 percent to 35 percent of the peak flow

Joe Scidmore reported on the problem with the Madison Street warning siren. An electrical problem was identified. Joe also mentioned that he has placed trees along the driveway at the new well. Thaddeus Kubisiak added that we have not yet maximized the \$1900 grant, from ATC, but we will by the end of the year

Police Chief's Report:

Chief Shawn Bauer reported on a new part time police officer. Mr. Bauer also mentioned that a revised officer schedule has been created and will be current through the end of the year.

Chief Bauer reported on a brawl that occurred at a local tavern
