# Minutes of the Regular Board of Trustees

### November 17, 2014

Meeting was called to order by President Frome at 6:30 pm

Roll Call:

Trustees Pokallus, Schafer, Day, Maurer, Hagen and Toufar were present

Minutes:

(Schafer)(Hagen) was carried to dispense the reading of the minutes and approve them as printed

<u>Citizen Comments</u>: There weren't any citizen comments

<u>Announcements:</u> There were no announcements

#### Public Works Report:

Joe Scidmore reported that the new broom is now installed on the Kabota, Christmas lights are ready to go up tomorrow morning and the new pickup truck has been delivered. Mr. Scidmore highlighted events at the tree institute at Green Lake. Joe mentioned that he is required to complete a project by June, 2015. He identified that an Emerald Ash Borer policy should be enacted upon

Scott Griepentrog reported that a hydraulic hose, on the front end loader, burst this morning. Mr. Griepentrog mentioned that the Christmas lights are ready, pending the availability of a bucket truck. Scott also mentioned that the roof drains are complete on the Olde Hall. He reported that work has begun on the concrete pile

Dean Smith reported that Well #1 is limited to 30 gallons per minute. Dean suggested that it may be the screen or the pump itself. The hydro fracking work will commence soon on Well #5 and the small water tower will be inspected next week

Chris Helgestad offered a report about the foam that was discharged from the oxidation ditch
