July 20th, 2015

Meeting was called to order @ 6:30 P.M. by President Frome

Roll Call:

Trustees Schafer, Maurer, Hagen, Day, Pokallus and Toufar were present

Minutes:

(Hagen)(Pokallus) was carried to dispense with the reading and approve the minutes as corrected with a correction to the word "lien" under item "D" of the Clerks Report

Public Comments:

Kim O'Haugherty inquired about the proposed skateboard park. Kim mentioned that she holds a list of names of parents who will help build the ramps. It was inquired whether the ramps are able to be built beforehand. It was noted that most construction firms are busy at this point in time

Pam Hoff inquired about the home, on West Clark Street, that sustained substantial fire damage last fall. Chief Bauer explained that a valuation of the property is required to continue the raze order process

Announcements:

Announcement of the public hearing for a variance application is scheduled for Monday, August 3 at 6:15 P.M.

Public Works' Report:

Dean Smith reported on last week's brush clean-up after the storm. Dean mentioned that there were some valves that were disturbed on the W Willow Drive project

Chris Helgestad reported that the Buse/Oak/Louisa project looked good. Chris mentioned that he is near capacity with the sledge storage tanks. He hopes that he will be able to apply the sledge soon

John Dunbar mentioned that the blue spruce trees, at the Veterans Memorial, look stressed. Trustee Pokallus highlighted that the trees are currently under warranty.

Police Chief's Report:

Chief Shawn Bauer reported on the home that sustained fire damage. Chief Bauer also reported on the proposed joint municipal court with Marshfield. Thaddeus explained that he received a copy of the final draft ordinance for this proposal

President's Report:

President Frome also mentioned that the grocery store scheduled a grand opening and customer appreciation ceremony on Wednesday from 11:00 A.M. to 1:00 P.M.
