# Minutes of the Regular Board of Trustees April 15, 2013

Regular meeting was called to order by President Kilty at 6:30 P.M.

#### Roll Call:

Trustees Frome, Gilbert, Pokallus, Staples, Hagen and Maurer were present

(Hagen)(Gilbert) was carried to forego the reading of the minutes and accept the minutes as printed

#### Citizen Comments:

Dale Mros inquired about the deer archery season within the Village limits. Dale also thanked the Village for the snow plowing efforts

### <u>Public Works Report</u>:

Dean Smith reported on the new well pump test. The levels of iron and manganese were lower than previously reported. Mr. Smith mentioned that he is investigating the possibility of a gas chlorination process for the water system as well

Dean indicated that there have been high frequencies of false alarms occurring at the water treatment plant. Further investigation will be done. Dean highlighted that the water tower was recently cleaned
