Minutes of the Regular Board of Trustees October 21, 2013

Regular meeting was called to order by President Kilty at 6:30 P.M.

Roll Call:

Trustees Frome, Pokallus, Staples, Gilbert, Hagen and Maurer were present

(Maurer)(Staples) was carried to dispense the reading of the previous meeting minutes and approve them as printed

Citizen Comments:

Clint Gosse reported about the progress of his new building. Clint thanked the Board for allowing him to move ahead with the development. Clint also inquired about the water and sewer laterals that were extended to his property. The water lateral, which was installed from the main, was a 6" pipe and both service laterals were not brought to the surface. Clint stated that the water service lateral should have been a 2" pipe and he understood that both service laterals should have been brought to the surface. The matter will be brought before committee

Public Works Report:

Scott Griepentrog spoke about the snow removal equipment. He said that the F350 has some electrical problems. The back-up alarm does not work as well as some of the lights. He said that these items will be corrected. Scott mentioned that the front end loader and the Grader are ready for the snow fall. The Sno-Go snow blower needs a few minor adjustments to the exhaust. The international truck requires a new dash cluster. The part will be ordered from Mid States Truck Service.

Scott mentioned that the road salt has been ordered. The lawn mowing has been slow with the lack of rain. Scott highlighted a concern about the new diesel fuel delivery service. He was told that the new vender cannot guarantee same day delivery

Chief Shawn Bauer reported that the Police Department received a donation from Land O Lakes for \$1000 toward a new squad car purchase
