# **Minutes of Regular Board of Trustees Meeting**

# Monday, July 9th, 2018 - 6:30 P.M.

President Frome called the meeting to order at 6:30.

The Pledge of Allegiance was recited.

## Roll Call

Trustees Hoes, Carolfi and Wienke were present. Trustee Schafer and Toufar were absent.

### Approval of Minutes

(Carolfi)(Hoes) was carried to dispense with the reading of the previous meeting minutes and approve them as printed.

### Public Works' Report

Paul Hensch reported on the progress on N LaSalle Street with the extension of culverts and reducing slopes of the ditching. At the WWTP the sludge tanks have been emptied and the process to turn them into the digester will begin in later in the month.

## Police Chief's Report

Chief Bauer reported that, in June, officers handled 184 calls for service, issued 105 traffic citations, 6 municipal citations, and 13 written warnings. Chief Bauer then updated the board on the K9 unit.

(Carolfi)(Hoes) was carried by a unanimous roll call vote to approve Change Order #1 on the WWTP Project for an increase of \$21,325.00.

(Carolfi)(Wienke) was carried to continue negotiations on a proposed lease with US Cellular for them to build a cell tower.

(Carolfi)(Hoes) was carried by a unanimous roll call vote to approve Ordinance 18-4 "An Ordinance to amend Chapter 253 Floodplain Zoning."

(Wienke)(Hoes) was carried to approve camping and late closure at ARC Park for the Brad Bauer Tournament.

(Carolfi)(Hoes) was carried to approve a renewal application for "Class B" fermented malt beverage and intoxicating liquor license for La Morenita located at 212 S Pacific Street.

(Hoes)(Carolfi) was carried to approve the application for an operator's License for Manuel Garcia.

(Carolfi)(Wienke) was carried by a unanimous roll call vote to approve the current vouchers with additions.
