Paul Hensch reported on a leaky curb stop repair. Between this repair and the Peach St hydrant repair, water production is down approximately 30%. He continued to report that the Well #6 repair is ongoing. Currently CTW is removing fine sand that was clogging the screen. Finally he told the Board that the DNR inspected the wastewater treatment plant and the inspection went very well.

Chief Bauer reported that the officers handled 180 calls for service, issued 15 traffic citations, 13 municipal citations, and 70 written warnings. The department investigated 2 traffic accidents.
