Roll Call

Approval of Minutes

(Carolfi)(Hoes) was carried to dispense with the reading of the previous Regular Board of Trustees meeting minutes and approve them as printed.

Public Works' Report

Paul reported that the Safe Drinking Water Loan Program application for Well #7 was submitted, the paving projects and the crack sealing has been completed, and that HAAS repaired soft spots on Depot St by digging them up and adding an additional foot of breaker.

<u>Police Chief's Report</u> Chief Bauer reported that, during the month of June, officers handled 271 calls for service, issued 63 citations, and 11 warnings.

(Carolfi)(Krause) was carried by unanimous roll call vote to approve **a** Developer's Agreement with Spencer Cold Storage.

(Carolfi)(White) was carried by unanimous roll call vote to approve 2023 Sewer Rates - setting the rates to: Land O'Lakes OM&R: \$5.35 per 1000 gallons to \$5.85 per 1000 gallons, with all Capital Charges paid separately. Residential: \$10.09 per 1000 gallons with a \$16.82 minimum to \$11.09 per 1,000 gallons with a \$18.48 minimum. Haulers: \$15.02 per 1000 gallons to \$16.02 per 1000 gallons.

Biological Oxygen Demand Surcharge: \$0.45 per pound (no change), Total Suspended Solids Surcharge: \$0.26 per pound (no change), Total Phosphorus Surcharge: \$6.84 per pound to \$7.47 per pound and a new Surcharge for Ammonia of \$0.51 per pound.

(Hoes)(Carolfi) was carried to approve an agreement with Town and Country Engineering to evaluate alternatives for the Hemlock Street lift station.

(Jicinsky)(Krause) was carried to approve a Temporary Class "B" Retail License for the Spencer Chamber of Commerce for their "Music in the Park" on August 3, 10, 17, 24, and 31, 2022, at the Lion's Park.
